**Primary Directors** are either workups on your first level not placed by others or Quick Start Directors placed anywhere in your organization that you personally sponsored.

**Retail Direct Customers** are those who purchase products to be shipped directly from DWG on your behalf.

**Retail Customers** are individual sales that you transact from your inventory.

**Reductions** in PGRV requirements for director overrides result from Primary Directors participation in the Monthly Autoship Program. The amount of their autoship will reduce the PGRV director override requirement of their Personal Sponsor.

#### \*DIRECTOR OVERRIDES

To qualify for the Director Overrides, you must have at least \$1000 PGRV of which at least \$100 is PV.

#### DIRECTOR OVERRIDES with COMPRESSION

To qualify for Override Compression, you must qualify for DIRECTOR OVERRIDES and your PGRV plus your PDGV must equal at least \$2500.

#### **DEFINITIONS:**

PV - (Personal Retail Volume) Your personal purchases.

PGRV - (Personal Group Retail Volume) Your personal purchase plus any purchases by your group. PDGV - (Primary Director Group Volume) The PGRV of your primary directors.
